This addendum is to answer vendor questions for RFP 9600-97: Coffee Vendor Services

- 1. Will the selected vendor be allowed to keep its coffee vending trailer/mobile food facility (MFF) parked over night at the designated area of operations, and is what type of security can NMC provide for the coffee vending trailer/mobile food facility (MFF)?**

In the event the County allows vendors to leave their trailer/equipment overnight, the County provides no security or assurances for the safety of the vendor's trailer, equipment, or contents, and assumes no responsibility for any loss, damage, or theft. All equipment is left on the property entirely at the vendor's own risk.

- 2. Will there be power outlets available at the designated spot for spot for operations?**

The designated area for operations is in front of Building 400. While there are no power outlets available at this location, the installation of two different types of power outlets is currently in process, with expected completion in August 20225. A meter will also be installed, and the selected vendor will be responsible for payment of the power usage from these outlets to County.

- 3. Will it be possible for the selected vendor to receive a badge with limited badge access to access certain/limited doors to enter the hospital, to discharge/dump the gray water. I.e. use an EVS closet for this purpose?**

Due to regulatory restrictions and logistics, Natividad will be unable to accommodate water disposal onsite. It will be the responsibility of the vendor to coordinate our outsource waste water removal to an offsite location.

- 4. If needed, can NMC's kitchen serve as a commissary approved facility for vendor?**

Yes. With approval from Natividad's Director of Food and Nutrition Services.
